The Following Rules and Regulations Will Apply to Takers:

1.) Installation of pipe from the main to the meter will be charged for at current construction costs as determined by the Commissioners. A \$200.00 deposit in advance is required from the applicant(s), any amount not used to be reimbursed, and any amount in excess of \$200.00 to be paid within 30 days. A minimum connection fee of \$2,500.00 is required to be paid at the time of application. Connection fees are determined by the size of connections made. See reverse side for connection fees.

2.) The undersigned owner agrees that the water meter, pipe line and all fixtures and fittings used in said installation between the main and the owner's property line shall be the property of the Town of Westminister, that all repairs or replacement of pipe on the owner's property shall be at the owner's expense and the undersigned owner hereby grants to the said Town and easement over the land of the undersigned owner for the purpose of laying, maintaining, repairing, removing or replacing the said pipe line as may be necessary to complete said installation.

3.) The undersigned owner agrees to abide by the provisions of this application and the Rules and Regulations established by the Public Works Commissioners as amended from time to time and agrees to release the Town from all suits and claims for damages arising from high pressure, lack of water, roily water and other causes outside the reasonable control of the Commission.

4.) A charge of \$75.00 will be made for turning off the water and the same charge for turning on the water each time the water department is requested to do so by the owner. The same charge will be made for turning off the water for non-payment of water bills and for turning it on after payment.

5.) The rates will be a minimum charge of \$275.00 a year, paid semi-annually, which will entitle the user to 40,000 gallons per calendar year. The rate for water used in excess of 20,000 gallons per semi-annual is \$5.50 per thousand gallons.
