FY11 COMMUNITY DEVELOPMENT BLOCK GRANT

Ms. Michaud moved that the Board sign a letter to the Montachusett Regional Planning Commission requesting assistance in the preparation of a Community Development Block Grant application for the development of Senior Center Design Plans and Housing Rehabilitation. The motion was duly seconded. The motion passed unanimously

USER AUTHORIZATION – MassEnergyInsight

Ms. Michaud moved that the Board authorize Heather Billings, Kevin Keena, and Karen Murphy to receive full access to the energy data of the Town of Westminster which is included in the Mass. Department of Energy Resources MassEnergyInsight energy reporting system. The motion was duly seconded. The motion passed unanimously.

BOARD OF SELECTMEN MEETING DATES

7:15 PM WESTMINSTER BUSINESS PARK EARTH REMOVAL PERMIT (CONT.)

Mr. Fairbanks opened the Westminster Business Park Phase II continuation hearing. He stated that the hearing would be continued following discussions on the layover station.

FITCHBURG COMMUTER RAIL LAYOVER STATION

Representatives from MART, MBTA, the Westminster Business Park and Senator Flanagan's office were on hand to discuss the proposed options for the site of the layover station.

Mr. Fairbanks moved that the Board of Selectmen vote to approve the location of a layover facility at Westminster Business Park, Lot I-4A, with the following understanding:

- ➤ The layover facility will only be used for overnight MBTA commuter rail parking, including light maintenance of the trains;
- ➤ Noise levels will be contained to under 50 decibels at 250 feet, and a whistle will not be required under normal circumstances;
- ➤ MART will provide information on its layover construction plans for comments from the Town so that the Town can provide input for any major mitigation it feels is necessary;
- ➤ In general, MART and the Town of Westminster will constantly dialog throughout the project;
- As a condition, a noise test following EPA standards will be performed to determine the number of decibels, the noise frequency, and amplitude.

Ms. Michaud seconded the motion. The motion passed unanimously.

It was agreed that the noise test would be conducted at the Fitchburg Station with the assistance of the Board of Health. The results would be presented at the next Board of Selectmen's meeting on April 26, 2010.

WESTMINSTER BUSINESS PARK EARTH REMOVAL PERMIT (CONT.)

After several questions were answered, Mr. Fairbanks moved that the Board issue a conditional approval and requested that Mrs. Murphy and Mrs. Tatasciore prepare a draft for the Board's review on April 26, 2010. The motion was duly seconded. The motion passed unanimously.

APPROVE CAFETERIA PLAN

Ms. Michaud moved that the Board approve and sign the Consent Resolution to establish a "cafeteria plan". The motion was duly seconded. The motion passed unanimously.
